## **Meeting Minutes Caribou Coffee – Red Wing, MN**

**Meeting Called to Order:** Called to order by Sue Gerdes at 7:15 pm at Caribou Coffee

5. **WSCA:** A letter from WSCA regarding personal insurance which is free were handed out to members in attendance.
6. **WI Horse Association:** Carole mentioned that there is a WI horse association that does points like GCSCA. Might be a draw for our shows. Carole will try to find out more.
7. **Horse Expo:** The horse expo sent a letter asking us to bid again. Carole will try to find other clubs that will partner with us so we don't have to provide horses. Maybe Lead Lope, posse, etc. Sue will check with the WI equestrian group (Brittany this year – not Jacque Stauffer). Babs will check with rideability about helmets and mounting blocks. More discussion needed.
